Technical Information

Granite

☐ The Granite material consists of 20 - 24 % Polymethylmethacrylate (Acrylic) Resin filled with 76 - 80 % of Fused Silicon Dioxide (Quartz Sand). The exception is our Natural White Granite which has 36 % of the above resin containing a blend of Silicon Dioxide and Pigmentation.

Material Origin

☐ Our Granite fillers are quartz which was formed about 200 million years ago in Bavaria, Germany it was originally Granite mountains in northern Europe which were destroyed during and after the ice age and were ground down by erosion and massive forces into Quartz sand which deposited in a massive alluvial bed. We extract this material by quarrying and then blend with pigment and binder and finally thermally fire it to impart the solid colour.

☐ Our resin is produced using raw materials from the UK, US, Italy, France, Spain and Germany, we use 25% recycled acrylic polymer in our resin to minimise the environmental impact of our suppliers.
